The *Department of Education, Division of Catanduanes*, through the 2022 Government Appropriation Act (GAA) intends to apply the sum of *Eleven Million Sixty-Eight Thousand Two Hundred Fifty-Nine Pesos and 77/100 (Php11,068,259.77)* being the Approved Budget for the Contract (ABC) to payment under the contract for the project *Repair/Rehabilitation of Classrooms-Batch 1 and Batch 2*. Bids received that exceed the ABC per Lot shall be automatically rejected at bid opening.

2. The **DepEd, Schools Division Office of Catanduanes** now invites bids for the above Procurement Project. Completion of the Works is required **90 calendar days per Lot**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II, Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184.
4. Interested bidders may obtain further information from Schools Division Office of Catanduanes and inspect the Bidding Documents at the address given below from **8:00 AM to 5:00 PM**.
5. A complete set of Bidding documents may be acquired by interested bidders on **August 9 – 30, 2022** from given address and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Ten Thousand Pesos (Php10,000.00) for Lot 1 and Five Thousand Pesos (Php5,000.00) for Lot 2**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
6. The Schools Division Office of Catanduanes will hold a **Pre-Bid Conference on August 16, 2022 at 9:00 AM at SDO- CID Office** through **face to face** which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at SDO-CID Office on or before **August 30, 2022 at 9:00 AM**. Late bids shall not be accepted.
8. All bids must be accompanied by bid security in any of the acceptable forms and in the amount stated in IIB Clause 15.

2. Bid opening shall be on **August 30, 2022 at 9:00 AM at CID Office** at the given address **kalaw through face to face**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. Prior to Bid Opening, a representative of bidders should present and submit to the BAC a Letter of Intent and a Special Power of Attorney stating the detailed activities which he/she will perform relative to the bidding at hand.
11. The *DepEd, Schools Division Office of Catanduanes*, reserves the right to reject any and all bids, declare a failure of bidding, not award the contract at any time prior to contract award in accordance with Section 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
