**Invitation to Bid for
CY 2024 Basic Educational Facilities Fund –
Repair/Rehabilitation of Classroom – Batch 1 at
Buenvista ES, Viga, Catanduanes**

1. The *DepEd, Schools Division Office of Catanduanes* through the *General Appropriation Act (GAA) CY 2024* intends to apply the sum of *Four Million Nine Hundred Ninety Nine Thousand Five Hundred Forty One Pesos and 47/100 Only (P 4,999,541.47)* being the Approved Budget for the Contract (ABC) to payments under the contract for *Repair/Rehabilitation Of Seven (7) Classrooms Under CY 2024- Basic Education Facilities Fund At Buenvista Elementary School, Viga, Catanduanes Project No. Infra 2024-02*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *DepEd, Schools Division Office of Catanduanes* now invites bids for the above Procurement Project. Completion of the Works is required **70 Calendar Days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *DepEd, Schools Division Office of Catanduanes* and inspect the Bidding Documents at the address given below from *Monday to Friday, 8:00 AM to 5:00 PM except during holidays*.
5. A complete set of Bidding Documents may be acquired by interested bidders on **June 24 to July 15, 2024, 1:00PM** from given address and website/s below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos only (PhP5,000.00)*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *through a copy of the receipt of the Official Receipt presented in person*.

6. The *DepEd, Schools Division Office of Catanduanes* will hold a Pre-Bid Conference¹ on **July 2, 2024, 10:30 AM** at *DepEd, Schools Division Office of Catanduanes Lobby* and/or through video conferencing or webcasting via <https://bit.ly/CY2024BEFFClassrmRepairBatch1>, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before **July 15, 2024 not later than 1:00PM. Late bids shall not be accepted.**
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on **July 15, 2024 1:30PM** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. *Prior to Bid-Opening, representative of bidders should present and submit to the BAC a **Special Power of Attorney** stating the detailed activities which he/she will perform relative to the bidding at hand and a **Letter of Intent**.*
11. The *DepEd, Schools Division Office of Catanduanes* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
