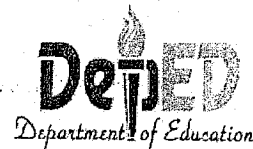

## INVITATION TO BID

CY 2016 BEFF

### PROVISION OF SCHOOL FURNITURE TO NEWLY CONSTRUCTED CLASSROOMS- BATCH 4

1. The *DepEd, Division of Catanduanes*, through the *General Appropriation Act (GAA) CY 2016* intends to apply the sum of **Two Million Eight Hundred Eight Thousand Seven Hundred Forty Eight Pesos and 85/100 Only (Php2,808,748.85)**, being the Approved Budget for the Contract (ABC) to payment under the contract for the procurement of *CY 2016 BEFF- Provision of School Furniture to Newly Constructed Classrooms- Batch 4*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *DepEd, Division of Catanduanes* now invites bids for **CY 2016- BEFF- Provision of School Furniture for Newly Constructed Classrooms- Batch 4**. Delivery of the Goods is required 90 days. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II Instruction to Bidders.

**Brief Description :** Armchairs (Non-Wood Based Materials) and Teacher's Table and Chairs-set (all wood)

**Delivery Site :** Door to Door delivery to recipient schools

**Contract Duration :** 90 calendar days from the date of acceptance of Notice to Proceed

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
4. Interested bidders may obtain further information from *DepEd, Division of Catanduanes* and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM.
5. A complete set of Bidding Documents may be purchased by interested Bidders from November 8, 2016 to November 28, 2016 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Five Thousand Pesos Only (Php5,000.00)**.

6. The **DepEd, Division of Catanduanes** will hold a **Pre-Bid Conference** on **November 15, 2016 at 8:00 AM** at **BAC Office**, which shall be opened to all interested parties.

7. Bids must be delivered to the address below on or before **November 28, 2016 at 9:00 AM** at **BAC Office, DepEd, Division Office**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **November 28, 2016 at 9:00 AM at BAC Office**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. Prior to Bid Opening, representative of bidders should present and submit to the BAC a **Special Power of Attorney** stating the detailed activities which he/she will perform relative to the bidding at hand and a **Letter of Intent**.

9. The **DepEd, Division of Catanduanes** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award without thereby incurring any liability to the affected bidder or bidders.
