

CY 2018 BASIC EDUCATIONAL FACILITIES FUND

ELECTRIFICATION OF UN-ENERGIZED SCHOOLS AND MODERNIZATION OF ELECTRICAL SYSTEMS ON-GRID SCHOOLS-BATCH 1

The *Department of Education, Division of Catanduanes*, through the 2018 Government Appropriation Act (GAA) intends to apply the sum of *Eight Million Nine Hundred Fifty Eight Thousand Five Hundred Thirty Two Pesos & 89/100 (Php8,958,532.89)* being the Approved Budget for the Contract (ABC) to payment under the contract for the *CY 2018 BEFF-Electrification of Un-Energized Schools and Modernization of Electrical Systems on Grid-Schools-Batch 1*. Bids received that exceed the ABC shall be rejected at bid opening.

The DepEd, Division of Catanduanes, through its **Bids and Awards Committee (BAC)** now invites bids for **CY 2018 BEFF- Electrification of Un-Energized Schools and Modernization of Electrical Systems on-Grid School- Batch 1**. Completion of the Works required **120 calendar days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section A, Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from Schools Division Office of Catanduanes and inspect the Bidding Documents at the address given below from **8:00 to 5:00 PM**.

A complete set of Bidding documents may be acquired by interested bidders on **March 20-April 9, 2018** from the address below and upon payment of the applicable fee of **(Ten Thousand Pesos) Php10,000.00** for the bidding documents, pursuant to the latest Guidelines issued by the GPPB.

The Schools Division Office of Catanduanes will hold a Pre-Bid Conference on **March 27, 2018** at **SDO, BAC Office at 9:00 AM** which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before **April 10, 2018 at 9:00 AM**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **April 10, 2018 at 9:00 AM at SDO, BAC Office**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

Prior to Bid Opening, a representative of bidders should present and submit to the BAC a Special Power of Attorney stating the detailed activities which he/she will perform relative to the bidding at hand.

The *DepEd, Division of Catanduanes*, reserves the right to reject any and all bids, declare a failure of bidding, not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.






