



INVITATION TO BID

1. The *Department of Education, Division of Catanduanes*, through the 2015 Government Appropriation Act (GAA) intends to apply the sum of **Eleven Million Seven Hundred Ninety One Thousand Eight Hundred Ninety Pesos Only (Php11,791,890.00)** being the Approved Budget for the Contract (ABC) to payment under the contract for the **CY 2015 Basic Educational Facilities Fund(BEFF)- Repair of Classrooms- Batch 1 and Batch 2**. Bids received that exceed the ABC per lot/cluster shall be automatically rejected at bid opening.

2. The **DepEd, Division of Catanduanes**, through its **Bids and Awards Committee (BAC)** now invites bids for the project **CY 2015 BEFF- Repair of Classrooms- Batch 1 and 2**. Completion of works is required **60 days per lot/cluster**. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II, Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from DepEd, Division of Catanduanes and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM, Monday to Friday.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Five Thousand Pesos (Php5,000.00) per cluster** to DepEd Division Office Cashier.


Prospective bidders are strongly encouraged to order from the PhilGEPS website: www.philgeps.net for them to be included in the Document Request List of the project.

7. Bids must be delivered to the address and on the date and time stated herein. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. A valid Bid Securing Declaration must accompany the bid(s) in lieu of the bid security.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. The *DepEd, Division of Catanduanes*, reserves the right to accept or reject any bid, to annul the bidding process and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
