2.	Delivery and Engagement (20%) Communication Skills: Does the teacher speak clearly, with appropriate tone and pace? Use of Digital Tools: Are appropriate tools (e.g., slides, videos, online platforms) used effectively? Learner Engagement: Does the lesson engaging?	
3.	Interaction and Classroom Management (30%) Responsiveness: Does the lesson address student questions and responses effectively? Behavior Management: Are classroom rules or norms maintained in the online environment? Inclusivity: Are all learners given opportunities to participate?	
4.	Technical and Online Adaptability (10%) Technical Preparedness: Are tools, materials, and the platform set up and functional? Adaptability: Does the teacher handle technical issues or unexpected challenges effectively?	
5.	Assessment and Feedback (10%) Clarity of Instructions: Are tasks and activities clearly explained? Assessment Methods: Are there meaningful ways to evaluate learner understanding? Constructive Feedback: Is feedback provided to support learning and improvement?



- 3. A pre-recorded video of demo-teaching shall be submitted as the entry, teacher may choose to have it with learners (make sure with parent's permission or consent) or without learners.
- 3. The duration of the video should be within 30 minutes.
- 5. Each participant will be evaluated by resident evaluators, the different master teachers, school heads and head teachers form different SDO's.
- 6. The decisions of the evaluators are final, and irrevocable.
- 7. All demo teachers will receive the following:
- an invitation letter address to their respective SDOs
- Certificate of attendance
- -certificate of participation
- certificate of evaluation indicated the scores obtained, signed by all evaluators
- 7. After the event, the panel of evaluators will choose the Outstanding Demo Teachers which will receive the following:
- a. Certificate as outstanding demo teacher
- b. Trophy
- c. Medal
- d. Evaluation sheet
- e. certificate of corroboration


