Hosted in a hybrid format—both in-person at the Loyola School of Theology, Ateneo de Manila University Campus, Quezon City, and online via Zoom—the conference will feature keynote presentations, panel discussions, and hands-on workshops. These sessions will be led by practitioners in education, technology, and policy, and will offer valuable opportunities for networking and collaboration with fellow educators and innovators from across the region and beyond.
