



RPS 2025-02: Probing the Readiness of Philippine Tourism Enterprises for RCEP and CPTPP

Amid various trade agreements that define trade rules and commitments for economies globally, the Regional Comprehensive Economic Partnership (RCEP) and the Comprehensive and Progressive Agreement for Trans-Pacific Partnership (CPTPP) have emerged as the largest and

most forward-looking agreements. The combined impact of these agreements is expected to promote deeper integration of member economies, resulting in sustained economic growth. However, these agreements also present threats, such as increased inequality and stiffer competition for local industries. Given these opportunities and threats to member economies, it is crucial to examine the readiness of enterprises for liberalization, especially in less developed economies like the Philippines. This study focuses on the Philippine tourism industry, given its economic significance. It underscores the continuously expanding economic role of tourism, identifies opportunities and threats, and assesses the readiness of tourism enterprises for trade liberalization. To address the research question of how tourism enterprises can prepare for the impacts of trade liberalization brought about by RCEP and CPTPP, a qualitative triangulation approach involving document reviews, key informant interviews, and focus group discussions was employed. The findings indicate that both trade agreements offer limited opportunities for tourism enterprises to participate in liberalization, as they are constrained by issues of mutual recognition and standardization of skills. PN 2025-04: Building Resilient Critical Industries for the Philippines in a Shifting Geopolitical Landscape

Amid geopolitical uncertainties, it is imperative for the Philippines to reassess its definition of critical industries to ensure economic resilience and national security. This *Policy Note* observes that the current definition of critical industries, primarily outlined in the Public Service Act of 2022, is limited to public utilities. The authors recommend expanding

this definition to include emerging sectors such as renewable energy and digital technologies. By doing so, the Philippines can better address vulnerabilities and strengthen its industries. Additionally, the authors suggest leveraging platforms like the Association of Southeast Asian Nations and the Asia-Pacific Economic Cooperation to foster multilateral collaboration, diversify supply chains, and enhance economic stability. Finally, they emphasize the importance of adopting a multihorizon strategy to mitigate risks, enhance domestic capacities, and secure sustainable growth. Click here to download the policy note.

The first issue of PIDS Policy Pulse for 2025 highlights promising trends and opportunities for the Philippines to sustain its growth and attain key targets toward becoming an upper-middle income economy. It calls on addressing gaps in equitable access to education and emphasizes improving tertiary education subsidy programs and services for public

and private institutions. This issue also underscores the need for universal access to clean water, sanitation, and hygiene facilities to prevent waterborne diseases like diarrhea, particularly in underserved communities. It also proposes a systematic approach to monitoring health and nutrition interventions for more transparent resource allocation. Another article examines how the country's aging population and shrinking households affect housing demand, urging investments in affordable housing projects and sustainable infrastructure. To navigate geoeconomic shifts, the issue also underscored the Association of Southeast Asian Nations' crucial role in maintaining unity and neutrality while adapting to changes in foreign trade policies. It advocates regional collective action to address disparities amid climate change, economic inequality, and rapid technological transformation. 


