- 1. This Office will be conducting the Evaluation and Selection of the 2020 Search for Brigada Eskwela Best Implementing Schools (elementary and secondary) on February 17-18, 2021, 8:00 a.m., at a venue to be announced later.
- 2. The participants to this activity are the PSDS/In-charge of the Districts, Division Evaluation and Selection Committee, School Heads or Brigada Eskwela Coordinators of the District Best Implementing Schools endorsed by the PSDS/In-charge of the District.
- 3. Only activities conducted from January to October 2020 based from the School Basic Education Learning Continuity Plan shall be rated.
- 4. Under generated resources, it must be supported with Deed of Donation, Deed of Acceptance, MOA, Acknowledgement Receipts or any document signed by the Donor and the Donee.
- 5. Creativity and innovation should have an Activity/Project Proposal signed by the school head with high impact to the learners, teachers and non-teaching benefited by the activity.
- 6. Alignment in the Brigada Eskwela Implementation in the light of the pandemic and calamities must be supported with letters to stakeholders, attendance sheets, activity/project proposal, and pictorials.
- 7. The Interim Policy Guidelines and Criteria for the Selection and Nomination of the awardees was released through Division Memorandum No. 034, s. 2021 dated February 2021.
- 7. Attached is the schedule of the evaluation and the composition of the Division Selection and Evaluation Committee.
