SUBJECT : **ADDENDUM TO DIVISION MEMORANDUM 199,S. 2023 INTERIM GUIDELINES OF THE LEARNERS GOVERNMENT PROGRAM (LGP) FOR THE SCHOOLYEAR 2023-2024**

1. This is in reference to Div. Memorandum 199 s. 2023 Interim Guidelines of the Learners Government Program (LGP) for the School Year 2023- 2024. The following is the indicative schedule of Supreme Elementary Learner Government and Supreme Secondary Learner Government:

May 29- June 9, 2023	School-based Elections
June 13-16, 2023	District Elections (for SELG)
July 7, 2023	DFSELG/DFSSLG Elections
July 18, 2023	RFSELG/RFSSLG Elections

2. To ensure consistency pursuant to DO 21s. 2019 named Learner Government Program(LGP) while SPG and SSG will be known as the Supreme Elementary Learner Government (SELG) and Supreme Secondary Learner Government (SSLG), respectively.
3. Relative to OUOPS 2023-03- memorandum the department mandates all elementary and secondary schools to facilitate learner-led clubs and organizations' elections and other relevant practices that will meaningfully support learners' initiatives and respond to varied context.
4. The Supreme Elementary Learner Government(SELG)/Supreme Secondary Learner Government(SSLG) is the highest student governing council in the school,

it is therefore advised that priority organization to be organized in the school shall be the SELG/SSLG before other learner – led clubs and organizations’.

5. The SELG/SSLG officers are the duly elected President, Vice President, Secretary, Treasurer, Auditor, Public Information Officer, Protocol Officer, and Grade Level Representatives.
6. Any SELG/SSLG Officer, except the Grade level Representatives, shall not be holding any other elective or appointive positions in other student clubs/organizations.
7. The School Head shall designate a qualified teacher as SELG/SSLG Adviser and endorse a copy of the designated to the Schools Division Office through the School Governance Operations Division – Division Youth Formation Coordinator.
8. All learner-led clubs and organizations’ elections are encourage to use the learner Government Election and Appointment Code.
