

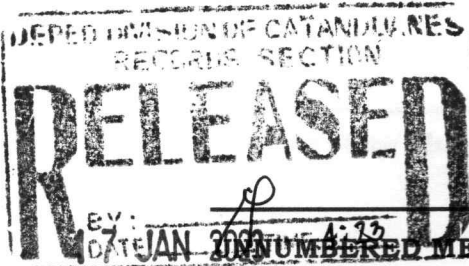



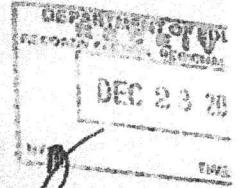

SUBJECT : Conduct of Integrated School Nutrition Model (ISNM) Online Conference

DATE : December 12, 2022

This Office, through the Bureau of Learner Support Services-School Health Division (BLSS-SHD), in coordination with the International Institute of Rural Reconstruction (IIRR), will conduct an online conference for Lighthouse Schools on January 12-13, 2023, via Zoom (link to be announced later). The conference aims to validate the conducted Online Survey on the status and activities on agrobiodiversity conservation/promotion and school food environment for garden resilience and healthy diets. The Bulletin of Information (Annex 1) is attached for ready reference.

As pre-work, ISNM program coordinators in all governance levels and those assigned in Lighthouse Schools (Annex 2) shall accomplish the survey questionnaire entitled "Assessment of Agrobiodiversity in Schools and Links to School Feeding, Environment and Nutrition Education" which can be accessed at https://bit.ly/ISNM_Agrobia, from December 19 to 29, 2022. The output of the said survey will contribute to the collaborative research of the IIRR on Fruits and Sustainable Healthy Diets (FRESH) which shall be processed to develop strategies for 2023-2025 to strengthen the implementation of the ISNM. The FRESH initiative is composed of work packages that aims to use an end-to-end approach to increase

fruits and vegetable intakes, improve quality of diet, as well as nutrition and health while improving livelihood and empowering youth.
