REITERATION ON TEACHERS' AND LEARNERS' PARTICIPATION IN THE NATIONAL LEARNING CAMP AND THE EoSY READING PROGRAM

To : Schools Division Superintendents
 All Others Concerned

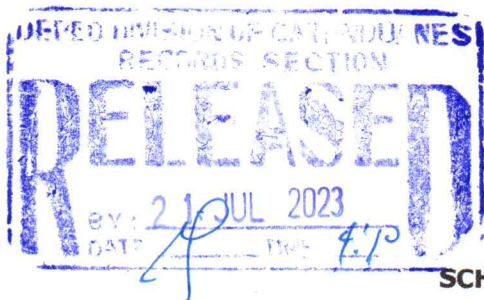
1. Pursuant to DO 14 s. 2023 (*Policy Guidelines on the Implementation of the National Learning Camp*) this office highly encourages the participation of teachers and learners in the implementation of the National Learning Camp and the EoSY Reading Program for Grades 1-3 to be conducted on July 24- August 25, 2023.
2. However, it is reiterated that the participation in the National Learning Camp and the EoSY Reading Program is VOLUNTARY. In no way should division or school authorities force teachers and learners to participate. The participation of teachers must come from an understanding of their critical role in improving learning outcomes and in acknowledgement of the need to strengthen their capacity as teachers.
3. On the other hand, the participation of learners must have the full consent of parents or guardians. The consent must not come from force or intimidation but from the understanding of the need for intervention or enhancement.
4. Division and school officials are enjoined to fully discuss the intent of the National Learning Camp and the EoSY Reading Program to all stakeholders.
5. Immediate dissemination of and strict compliance with this memorandum is desired.



**REITERATION ON THE VOLUNTARY PARTICIPATION OF TEACHERS
IN THE NATIONAL LEARNING CAMPS**

1. Pursuant to DepEd Order (DO) No. 014, s. 2023 titled Policy Guidelines on the Implementation of the National Learning Camp (NLC), the Office of the Secretary reiterates that the participation of teachers in the NLC is **strictly voluntary**.
2. In view of such, no teacher shall be forced to participate in the NLC. It is likewise emphasized that the non-participation of the teachers in the NLC shall not be taken against them in any manner.
3. This Office enjoins the division and regional offices to ensure the proper implementation of the aforesaid DO, particularly on the voluntary participation of teachers.
4. Immediate dissemination of and strict compliance with this Memorandum is desired.
