Despite the improvement of the pandemic situation due to the extensive vaccination program and proposed limited face to face activities, still the testing opportunities to assess college applicants are very limited today. There is still the imminent threat of getting contaminated by the Covid19 when college applicants for Academic Year 2022-23 are invited to visit at the designated venue where they are to take the College Entrance Examination (CEE). This unfortunate situation continues to suggest that there must be a more flexible and inclusive approach of assessing the college applicants to the university. Thus, the Guidance, Counseling and Testing Office (GCTO), shall continue with its proposed and adapted Campaign and Orientation Program which was approved the previous academic year. There will be no administration of CEE, instead the qualification of the college applicants shall be assessed through their General Weighted Average (GWA) in Grade 10 and 11 so as to identify their academic performance in the general education and specialized courses relevant to the courses they are planning to enrol in the university.

With this, we seek your assistance by also providing official communication to all School Heads/Principals to accommodate us during our Coordination Meetings with them and also to assign their respective Designate Guidance Counsellor or any other capable personnel to facilitate the proper implementation of such program in their own campuses to assure effective delivery of its objectives.

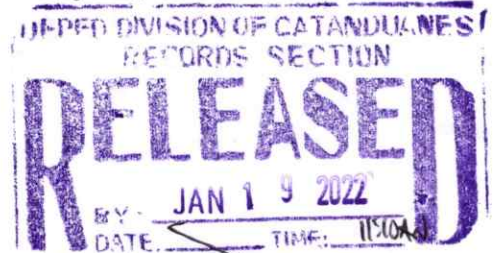
