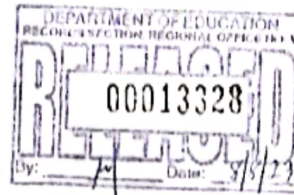

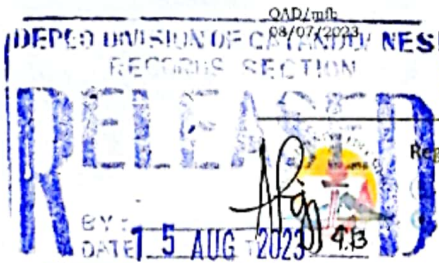

1. This Office hereby disseminates DepEd Memorandum OASOPS No. 2023-149 dated August 2, 2023 entitled: "Advisory on the Opening of Classes for School Year 2023-2024 for Private Schools".
2. As stipulated in the said Memorandum, **private schools may begin operations earlier than public schools, provided that classes open on the 1st day of June but not later than the last day of August.**
3. Relative thereto, private schools must submit their school calendar for SY 2023-2024 through their respective Schools Division Offices (SDOs). Subsequently, the SDOs shall submit the evaluated Calendar of Activities to this Office, properly endorsed by the Schools Division Superintendent.

SUBJECT : **ADVISORY ON THE OPENING OF CLASSES FOR SCHOOL
YEAR 2023-2024 FOR PRIVATE SCHOOLS**

DATE : August 2, 2023

In view of the opening of classes for School Year 2023-2024, **private schools may begin operations earlier than public schools, provided that classes open on the 1st day of June but not later than the last day of August**, as stipulated in Republic Act (RA) No. 11480 or an act amending Section 3 of RA No. 7797, otherwise known as *An Act to Lengthen the School Calendar from Two Hundred (200) Days to Not More Than Two Hundred Twenty (220) Class Days*.

Likewise, private schools must submit their school calendar to their respective regional offices to validate the requirements.
