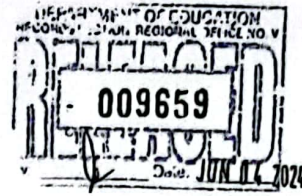

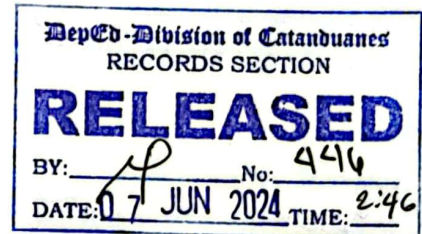

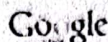

8. ETCOR's various advocacy/charitable activities.

Guidelines for Collaboration/Partnership with ETCOR Educational Research Center Inc.

Schools, universities or organizations who wish to have a collaboration/partnership with an external institution or organization like ETCOR Inc., with the possibility of forging/establishing a MOU/MOA, shall be the ones to initiate the said possibility of a collaboration/partnership by writing a Letter of Intent to ETCOR Inc.

The letter shall be written and signed by the representative of the school, university or organization who wishes to have a collaboration/partnership with ETCOR Inc. Said representative may be the president, department head, principal, or other representative/s depending on the scope or unit of the intended collaboration or partnership. The representative shall be duly authorized by the school, university or organization to initiate/execute the possibility of the said collaboration or partnership.

In the said letter, the possibility of forging or establishing a collaboration or partnership with ETCOR Inc., entering into a MOU, MOA, shall be stated. The specific areas of collaboration or partnership where the two parties (the party writing the letter and ETCOR Inc.) can help each other shall be stated. The party writing the letter shall specify in what areas or services or projects of ETCOR Inc. it can possibly benefit (research consultancy services of ETCOR, research journal publication, magazine publication, Book Publications, ETCOR Awards, trainings and conferences, partnership for advocacy/charitable activity, human resources collaboration, etc.). As part of the possibility of a mutual agreement, the party writing the letter shall also state in what areas or services it can also help ETCOR. The possibility of the conduct of an initial meeting (either virtually or face-to-face) shall be stated.

If possible, even before the conduct of the initial meeting, if the party already has specific details of the proposed collaboration (specific activities, schedules, persons-in-charge, responsibilities of the parties, etc.), said details shall already be included in the letter of intent. If

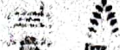
