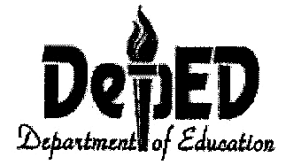

The **DepEd, Division of Catanduanes**, through its **Bids and Awards Committee (BAC)** now invites bids for the above-mentioned works. Bids received that exceed the ABC per lot/cluster shall be rejected. Late bids shall be rejected. Evaluation and award shall be made on a per lot basis as one (1) lot. Bidder may bid for one, more than one or all of the lots.

Prospective bidders must have completed a similar contract within ten (10) years from the deadline date of submission and receipt of bids with an amount at least fifty percent (50%) of the ABC to be bid.

Bidding is restricted to Filipino citizens/sole proprietorships, organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Open competitive bidding will be conducted using non-discretionary pass/fail criterion, evaluation and post-qualification procedures specified in the Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act".

The Bidding Documents may be inspected or purchased at DepEd, Division Office, Records Section upon payment in cash of a non-refundable fee, in the amount of Ten Thousand Pesos (Php10,000.00) per lot/cluster by interested bidders to DepEd Cashier. Only bidders that purchased the Bidding Documents will be allowed to submit bids.

Prior to Bid Opening, representative of bidders should present and submit to the BAC a **Special Power of Attorney** stating the detailed activities which he/she will perform relative to the bidding at hand.

The *DepEd. Division of Catanduanes*, reserves the right to accept or reject any and all bids, declare a failure of bidding, not to award the contract, or annul the bidding process without thereby incurring any liability to the affected parties.
