1. Hereunder are some changes and additional guidelines/information on the conduct of the Catandungan Festival Padadyao sa Tinampo.
2. The contest is definitely scheduled on October 25, 2013, 1:00 o'clock in the afternoon from the Provincial Capitol Ground to Virac Plaza Rizal.
3. There will be two (2) sets of the board of judges. One group will judge during the Padadyao sa Tinampo and the other group during the showdown presentation at Virac Plaza Rizal using the same criteria for judging. The average rating will determine the winning group (As unanimously approved by the committee).
4. The place and time of assembly of the participating groups is at Provincial Capitol Ground at 12:30 pm where the drawing of lots among the municipal/district coordinators will be done.
5. Participating groups from the Municipalities of Baras, Bagamanoc, Pandan, Caramoran, Viga, Gigmoto shall be billeted at Catanduanes National High School and Virac, BAto, San Andres, San Miguel and Panganiban at Virac Pilot Elementary School.
6. The Division Teachers and Employees Chorale will lead the singing of the Philippine National Anthem and Doxology during the program. As such, members of the Division Chorale are advised to report to the Division Office Terrace for practice on October 25, 2013 at 8:00 o'clock in the morning. To take charge of the practice is Mrs. Myrna A. Aldea.
