

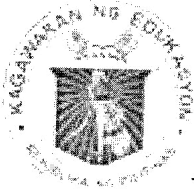


**CORREGINDUM TO THE DIVISION MEMORANDUM NO. 93, S.2014**  
**Re: THE 2014 KINDERGARTEN FESTIVAL OF TALENTS**

1. Per Regional Memorandum, N. 108, s. 2014, this division will conduct the 2014 Kindergarten Festival of Talents on November 28, 2014 at the Division Office Conference Hall A, to start at 7:30 in the morning.
2. The scheduled activity is for both public and private schools instead of the separate date for both as stated in the Division Memorandum No. 93, s. 2014.
3. The contestants from the private schools will join in the zonal contest of their respective zone/area.
4. The zonal winners will represent the zone in the division level contest. Each zone will be represented by 20 contestants to the division level, hence a total of 80 contests from the four (4) zones.
5. Below is the schedule of Zonal Level Contest per zone and venue of the contest.

  - c. Certificates (participation, appreciation/commendation, etc.
7. No. registration fee shall be charged to all participants. Materials, supplies and travelling expenses of the contestants, DepEd personnel involved, coaches, school heads and other school officials during the competition shall be charged to school MOOE/local funds, SEF, PTA and other sources subject to usual accounting and auditing rules and regulations.
