- 1. In compliance to Regional Memorandum No. 155, s. 2013 entitled, "Regional Festival of Talents (Elementary)", this division has scheduled the conduct of the 2013 Division Festival of Talents (Elementary) in Edukasyon sa Pagpapakatao (EsP) on December 4, 2013 at the Division Office Conference Hall A, with the theme "Learn, Grow, and Succeed in K to 12 Education".
- 2. This competition aims to encourage the learners/ pupils to show their skills in this specific learning area as they develop their level of confidence and competence through friendly competitions.
- 3. Participants to this festival are the district first place winners in Poster Making and in Comic Strip Making who in turn the champion (first place winner) in the division level shall represent the division to the Regional EsP Festival of Talents (Elementary Level) on December 13, 2013 at 8:00 A.M. in the Robredo Coliseum.
- 4. Specific guidelines on the mechanics of the contests are contained in the attached enclosures together with the different committees who shall assist in running these division events.
- 5. Coaches are tasked to pay a registration fee of Fifty Pesos (P50.00) for simple snacks of the board of judges and other incidental expenses such as reproduction of contest photos/pictures, certificates, medals relative to the conduct of the contests. These coaches shall register once in case they tag along more than one contestant.
- 6. Travel and other expenses relative to this activity shall be charged against the local/school funds subject to the usual accounting and auditing rules and regulations.
- 7. Widest dissemination of and strict compliance to this urgent memorandum is desired.

# **GUIDELINES IN THE CONDUCT OF THE ESP FESTIVAL OF TALENTS**

#### I. POSTER MAKING- 8:30 A.M.

- 1. Contestant must be a grade IV, V, VI pupil who is the first place winner in the district level competition.
- 2. Contestants should bring ¼ illustration board and the other appropriate material, like crayons, oil pastel, and water color. Only three colors will be used in the contest. No borrowing of materials from other contestant.
- 3. Specific theme will be given on the spot.
- 4. Contestant is given one (1) hour to finish his/ her poster.
- 5. Coaches are prohibited to give any material during the contest proper. If ever you want to give something, please course it through the contest administrator/ coordinator.
- 6. Coaches are not allowed inside the contest area/ hall while the contest is going on.
- 7. Any violation of the rules will earn deduction of 15 points from his total score.
- 8. The decision of the board of judges is final.

## II. COMIC STRIP MAKING- 8:30 A.M.

- 1. Contestant must be Grade IV, V or VI who is the first place winner in the district level competition.
- 2. Filipino will be used in the dialogue.
- 3. Four pages (4-page) half of short bond substance 20 (horizontally cut) and pencil shall be used by the contestant to portray the message of the pictures and dialogue.
- 4. The specific theme will be given on the spot.
- 5. Contestant shall be given 1 ½ hours to finish his/ her comic strip.
- 6. Contestant is expected to bring his/ her own materials, including his/ her own snacks.
- 7. Coaches are prohibited to give any material during the contest proper.
- 8. Coaches are not allowed to stay at the contest hall, during the contest proper.
- 9. Any violation of the rules will earn deduction of 15 points from his total score.
- 10. The decision of the board of judges is final.
