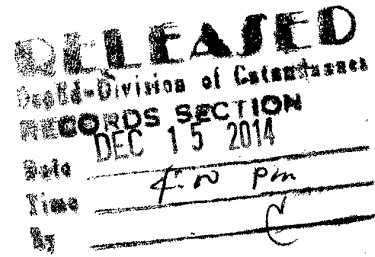

SUBJECT: SCHEME TO COMPLETE THE 120-FEEDING DAYS OF THE
SCHOOL-BASED FEEDING PROGRAM (SBFP)

DATE: December 15, 2014



The School-Based Feeding Program is now on its full implementation starting December 10, 2014, primarily to improve the nutritional status of the severely wasted beneficiaries after the 120-feeding days.

As per guidelines, the number of feeding days **CAN NOT BE SHORTENED**, hence, we have designed a scheme to complete the 120 feeding days. As agreed during the Regional Mancom Meeting last December 11, 2014, feeding shall be done Mondays to Fridays (even Holidays) plus breakfast every Monday and Friday to offset the Saturdays and Sundays (still, 7x a week).

It is stipulated in the DepEd Order No. 37, s. 2014 and SBFP Operational Guidelines (E. Awards & Incentives, # 1. Granting of Service Credits), that services rendered by the teacher who are members of the SBFP Core Group during holidays are eligible for service credits in accordance to the suggested scheme to complete the 120-feeding days.

Attached is the new suggested Scheme to complete the 120-feeding days.
